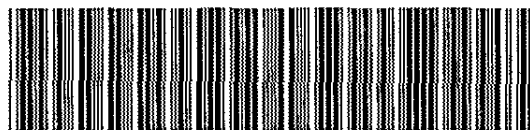

GRAND BUILDING CORPORATION (the "Corporation")

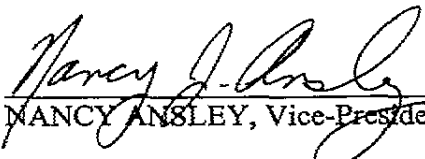
ARTICLE II. AUTHORIZATION OF ARTICLES OF DISSOLUTION
