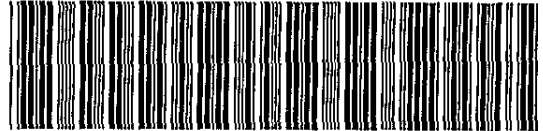

The dissolution of the Corporation was authorized on January 18, 2003.


ARTICLE III


All shareholders approved the dissolution of the Corporation; accordingly the number of shares cast for dissolution was sufficient for approval. Voting by voting group was not required.
