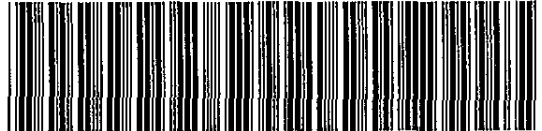

Pursuant to the provisions of section 607.1006, Florida Statutes, this Florida profit corporation adopts the following articles of amendment to its articles of incorporation:

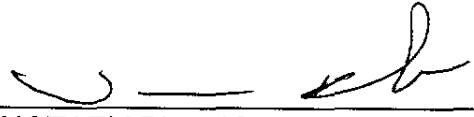
- FIRST:** Amendment adopted: **ARTICLE I** is being amended to change the name of the corporation to **HARONDA REALTY, INC.**
