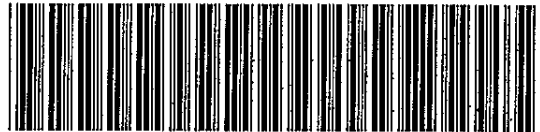

At that point in time the company's business outlook was poor and such a failure seemed imminent. However, these circumstances did not develop. My wife, Marjorie M. Bentz and I, as the only stockholders, directors and officers of Bentech and Associates kept the incorporation active over the past years to provide us a fall back position in case of failure of any of my subsequent employers as the manufacturing plant I worked at changed ownership.

I am now retired and it is no longer necessary for us to maintain the incorporated status of Bentech and Associates, Inc.
