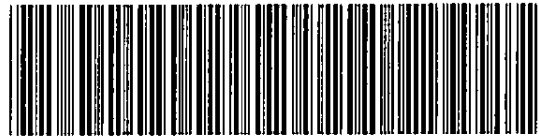

ADOPTION OF AMENDMENT

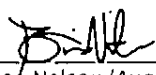
