ARTICLES OF AMENDMENT INFORMATION MANAGEMENT ALTERNATIVES

These Articles of Amendment are filed pursuant to Florida Statute Section 607.1006, to reflect an amendment to the Articles of Incorporation of INFORMATION MANAGEMENT ALTERNATIVES PLUS, INC., and in connection therewith, the undersigned officers, acting upon authority of the Board of Directors of INFORMATION MANAGEMENT ALTERNATIVES PLUS, INC., and upon authority of all of the shareholders of this Corporation, hereby set forth as follows:

- 1. The name of this Corporation is INFORMATION MANAGEMENT ALTERNATIVES PLUS, INC.
- 2. The Articles of Incorporation of INFORMATION MANAGEMENT ALTERNATIVES PLUS, INC. have been amended by deleting Article I in its entirety and by substituting in lieu thereof the following Article:

"ARTICLE I - NAME
