Please find enclosed a Baywood Technologies, Inc check, number 17373, for One Hundred Fifty Dollars and Zero Cents (\$150.00). This check represents the 1998 Annual report filing fee and Supplemental corporate fee.

Request for Abatement of Assessed Penalties

Baywood Technologies, Inc respectfully requests that the penalties be abated due to reasonable cause.

Beginning in early 1995, the owner hired an internal CPA - Controller to handle the financial and tax matters of the company. Prior to the employment of the internal CPA - Controller, the owner conducted business in full compliance with the respective tax laws and regulations. The owner was unaware the internal CPA - Controller did not appropriately administer the respective obligations of the Company. Had the owner known of the failure of the internal CPA - Controller to properly administer the respective obligations, corrective actions would have occurred.

The internal CPA - Controller was dismissed in early 1998, and I have just recently received the second notice from the Florida Department of State. The owner was lead to believe by the dismissed CPA -Controller that the company was operating within the laws and regulations of the State of Florida, Department of Corporations. The owner relied upon the dismissed CPA - Controller's knowledge and proper administration of the respective obligations. The owner is now in full compliance with the laws and regulations of the State of Florida, Department of Corporations.

Therefore, based upon the above disclosures, the owner respectfully requests full abatement of the penalties assessed due to reasonable cause. The owner relied upon the duties of the dismissed CPA - Controller and was without knowledge that the delinquency existed until the second notice from the Department of State.
