THIRD ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION

Pursuant to the provisions of Chapter 607, Florida Statutes, ELASTIZELL CORPORATION OF FLORIDA, INC., the undersigned corporation, adopts the following Articles of Amendment to its Articles of Incorporation:

FIRST:

The name of the corporation is ELASTIZELL CORPORATION OF FLORIDA, INC.

SECOND:

Article Three, Capital Stock, of the Articles of Incorporation, as amended October 3, 1989, is hereby further amended in its entirety so as to read, after amendment, as follows:

"Article Three: Capital Stock. This Corporation is authorized to issue Twenty Thousand (20,000) shares of One Dollars (\$1) par value common stock. One Hundred (100) shares shall be voting common stock, and Nineteen Thousand Nine Hundred (19,900) Shares shall be non-voting common stock. Voting common stock shall be entitled to vote on all corporate matters. Non-voting stock shall not be entitled to vote on corporate matters. Except for voting rights, the voting common stock and non-voting common stock shall be equal in all respects; including but not limited to, equal rights to profits, assets, distributions, and liquidation proceeds."
