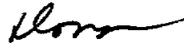

FOURTH: The effective date of dissolution for the corporation is December 31, 1999.

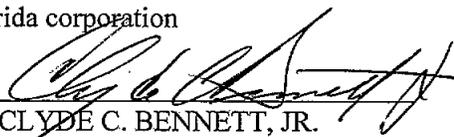
FIFTH: All debts, obligations and liabilities of the corporation have been paid or discharged.
