ARTICLES OF AMENDMENT TO  
ARTICLES OF INCORPORATION OF  
RATTLESNAKE POINT, INC.

The undersigned Corporation, in accordance with the Florida Business Corporation Act and its Bylaws, hereby adopts the following Amendment to its Articles of Incorporation:

1. Article IV of this Corporation's Articles of Incorporation is hereby amended in its entirety so as to read, after amendment, as follows:

ARTICLE IV  
CAPITAL STOCK

This corporation shall be authorized to issue Ten Thousand (10,000) shares of \$1.00 par value stock divided into two classes of stock: Class A Voting Common and Class B Non-Voting Common. Said classes of stock shall be identical in all respects except that shareholders owning Class B Non-Voting Common stock shall have no voting rights of any kind or nature whatsoever. The par value and authorized issue of such classes of stock shall be as follows:

Class A Voting Common	\$1.00 per share	1,000 shares
Class B Non-Voting Common	\$1.00 per share	9,000 shares



2. There are currently issued and outstanding 1,000 shares of common stock of the Corporation held by the sole shareholder of the Corporation. Upon the filing of this Amendment the 1,000 shares of currently issued common stock shall be exchanged for ten (10) shares of Class A Voting Common Stock and nine hundred ninety (990) shares of Class B Non Voting Common Stock, and appropriate stock certificates shall be issued to the current shareholder to evidence the exchange of shares of stock.

3. This Amendment has been adopted by unanimous Written Action of all of the Directors and the sole Shareholder of the Corporation on December 18, 2019, which vote is sufficient for approval.
