I recently went on the internet to get the document number for my corporation, The Marc X, Inc. (J51337) and discovered that it was inactive. Upon calling your offices, I was told that I had been inactive since 1995 because no corporate report had been filed.

The last corporate report filed was filed by an accounting firm, H.J. Swart and I ceased using that firm in 1995. I did not receive the renewal for the report since it was sent to a P.O.
