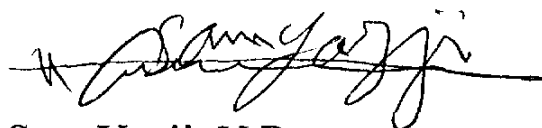
I am sending this letter to confirm my phone conversation with Mr. Scott and Mr. Andy.
