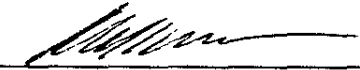

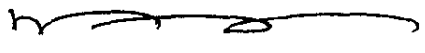
1. The name of the corporation is hereby changed to "Alexander Christine & Maureen Sullivan Christine, P.A."
