

Pursuant to F.S.A. § 607.1002, the undersigned, WALLIPS ENTERPRISES, INC., Florida corporation, hereby adopts the following Articles of Amendment to the Articles of Incorporation:

The following articles of the Articles of Incorporation of WALLIPS ENTERPRISES, INC., filed on February 4, 1987, are hereby amended as follows:

ARTICLE I.

The name of the corporation shall be SANIBEL TREE SERVICE, INC.


2. The date of adoption of the Amendment by the Shareholders and Board of Directors was November 1, 2001.
