Pursuant to the provisions of the Professional Service Corporation and Limited Liability Company Act (chapter 621, Florida Statutes), and section 607.1003, Florida Statutes, the undersigned corporation, originally incorporated on February 4, 1987, pursuant to a resolution duly adopted by its shareholders, adopts the following amended and restated articles of incorporation:

ARTICLE I

The name of the Corporation is: Gilchrist Ross Crowe Architects, P.A..

ARTICLE II

The street address of the principal office of the Corporation is: 413 All Saints Street, Tallahassee, FL 32301.

ARTICLE III

The specific purpose for which the Corporation is organized is:

- a. To engage in every phase and aspect of the professional practice of architecture; to investigate, evaluate, plan, and design the construction or erection of buildings, structures, and other projects; to provide professional advice on any such construction; and to supervise and inspect construction for the purpose of assuring conformity with plans and specifications.
