#### ARTICLES OF AMENDMENT TO

# ARTICLES OF INCORPORATION OF NAVONOD DEVELOPMENT CO., INC.

Article III of the articles of incorporation of NAVONOD DEVELOPMENT CO., INC. was amended by the corporation's board of directors on May 24, 2011. The corporation is filing these articles of amendment to articles of incorporation pursuant to F.S. 607.1006.

- 1. The name of the corporation is **NAVONOD DEVELOPMENT CO., INC.**.
- 2. Article III of the articles of incorporation of NAVONOD DEVELOPMENT CO., INC., was amended as follows:

## ARTICLE III AUTHORIZED SHARES


The Corporation shall be authorized to create and issue seven thousand five hundred (7,500) shares of common stock, having a par value of One Dollar (\$1.00) per share, which may be designated by the Board of Directors of the Corporation as either Voting Common Stock or Non-Voting Common Stock. The holders of the Voting Common Stock shall be entitled to vote to elect members of the Corporation's Board of Directors. The holders of Non-Voting Common Stock shall not be entitled to vote to elect members of the Corporation's Board of Directors. The Bylaws shall specify the terms and conditions for the conversion of Non-Voting Common Stock into Voting Common Stock and the conversion of Voting Common Stock into Non-Voting Common Stock.

3. The foregoing amendment to articles of incorporation was duly adopted by the board of directors on AA 26, 2011. Shareholder action is not required for amending the articles of incorporation.


