

It reports to IRS as a corporation, and to Massachusetts as an individual. The name at inception and still the same is Scargo Knolls Realty Trust. The articles of organization were filed with Massachusetts under that name, and no change has been made in the ensuing years.

I do not know how the title Scargo, Inc came into being, and would appreciate your assistance in correcting the situation. To the best of my knowledge no articles have been Florida, since it is not a Florida corporation.


