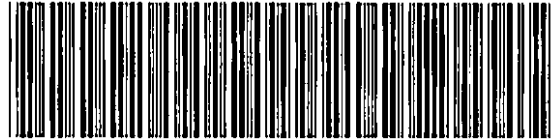

SECOND: Amendments adopted:

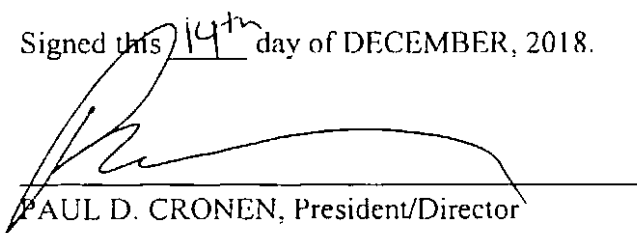
ARTICLE I. - NAME
