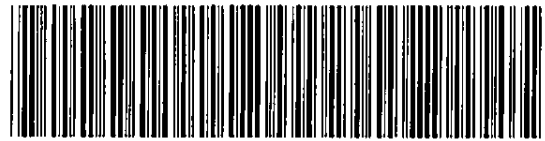

Dissolution of the corporation was approved and authorized on 2/14, 2024.


ARTICLE III. APPROVAL OF DISSOLUTION
