ARTICLES OF AMENDMENT OF THE ARTICLES OF INCORPORATION OF MIAMI FREE ZONE SERVICES, INC.

Pursuant to the provisions of Section 607.1006 of the Florida Business Corporation Bit.

MIAMI FREE ZONE SERVICES, INC., a Florida corporation (the "Corporation"), adopts the following articles of amendment to its Articles of Incorporation.

ARTICLET

The name of the Corporation is MIAMI FREE ZONE SERVICES, INC.

ARTICLEII

Article I of the Corporation's Articles of Incorporation is deleted in its entirety and the following is substituted in its stead:
