Pursuant to the provisions of Section 607.1006, Florida Statutes, Circle C Ranch South Tampa's Junior Academy, Inc. (the "Corporation"), hereby adopts the following Articles of Amendment to its Articles of Incorporation filed with the Florida Secretary of State on April 10, 1987 (the "Articles"):

Article I - Amendment

1. Name of Corporation. The Articles are hereby amended to change the name of the Corporation from "Circle C Ranch South Tampa's Junior Academy, Inc." to "Circle C Ranch Academy, Inc.".

Article II - Adoption / Effective Date of Amendment
