Let me start this letter by telling you that when I sent in the post card requesting the application to renew form, I did not receive the form at the time you would have expected for it to arrive in my hands.

The reason for this is as follow: I am in a 12 unit office building. All office doors open the the outside of the building. There is a free-standing mail box for receiving mail and each of us has a key to our incividual box. This box belongs to the US Post Office and none of us including the manager is able to enter any of the other boxes. During this year, we have had two vacancies.
