ARTICLES OF AMENDMENT

OF

LIBERTY BAIL BONDS, INC.

Pursuant to the provisions of Section 607.1006, Florida Statutes, Liberty Bail Bonds, Income Florida corporation (the "Corporation"), adopts the following Articles of Amendment to its Articles of Incorporation:

- 1. The name of the Corporation is Liberty Bail Bonds, Inc.
- 2. That Article I of the Articles of Incorporation of the Corporation is hereby amended and replaced in its entirety to read as follows:

Article I - Name

The name of the Corporation is G. Clarke Bonding, Inc.

- 3. The foregoing amendment was approved by the Board of Directors of the Corporation by unanimous Written Consent on August 11, 2005, and it was recommended that the Articles of Amendment be presented to the Shareholders for adoption at a special meeting.

- 5. The foregoing amendment shall become effective when filed with the Secretary of State, State of Florida.
