
Dear Sirs:

Please find enclosed a current Annual Report form along with a check for \$900.00 covering the years 2001-2006, for which no reports were filed.

Beginning in late 2000, a massive road project was begun, which totally paralyzed the intersection at which our business was located. We experienced lengthy interruptions in utilities, mail, etc. and did not receive the notice or form to file our annual report for 2001.
