**ARTICLES OF DISSOLUTION AND

1. NAME OF CORPORATION: The name of the corporation being dissolved is JACK HAZAN, D.M.D., P.A. (the "Corporation").


2. DATE OF INCORPORATION: The original Articles of Incorporation of the Corporation were filed on 5/11/87.
