Dear Sir or Madam,

We have recently received a notice of intent to dissolve, in reference to the 2005 corporate annual report for Project and Construction Welding, Inc. (d.b.a. I M S), via regular mail.

Upon researching this matter, I have confirmed that this report was in fact not filed, due to miscommunication between myself and an employee at our accountant's office. This year was the first time that the annual report notice reminder was received via a post card, with the information on it that the report could be printed on line. Since this was the first time that it was done this way, I had talked to our accountant's office and it was agreed that the form would be down loaded from this office. Unfortunately, the person I spoke with understood this to mean that it was going to be completed from this office as well. However, I meant only that it would be printed here, and it would then be sent to the accountant's office for preparation and return to P.C.W. for signature and then mailing. This has been our standard procedure for many years regarding various tax forms. It was sent to the accountant's office, where it was assumed that it was for a file copy only, and consequently was not completed by them. Regrettably, I also overlooked that the original return was never completed and returned to this office. Upon closer inspection, I see that there really was no preparation involved, however, the long practice of simply delivering all tax related forms to their office caused me to do this with this return as well. We are a small company, with only a few employees, and as office manager I have many daily duties and responsibilities, with my main focus being on serving our customers and meeting our deadlines to them.

This report not being filed was done by human error, and it has been filed on time for the preceding seventeen years. With this in mind, we respectfully request your assistance in removing the \$400.00 penalty fee. If it cannot be removed completely, can it possibly be reduced?
