ARTICLE I

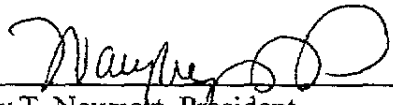
The name of the professional association shall be:

MARY T. NEWPORT, M.D., P.A.

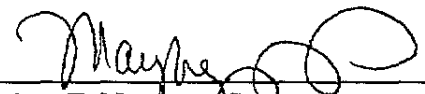
