The Florida Division of Corporations' database indicates that SSK Investment Corporation was administratively dissolved in 2002 for failure to file an annual report. Mr. Stanley W. Kahn, President of SSK Investment Corporation never received the Annual Report.

Mr. Kahn mailing address for thirty plus years was P.O. Box 337, 8850 North U.S. Highway 1, Wabasso, Florida 32970. In January of 2002, Mr. Kahn changed his mailing address from the Wabasso address to 8802 North U.S. Highway One, Sebastian, Florida 32958. Mr. Kahn was having difficulty receiving mail at the 8850 North U.S. Highway 1, Wabasso, Florida 32970 address. It is my client's understanding that any mail addressed specifically to the Wabasso address, excluding the post office box number, was being returned to the sender, instead of being forwarded to the new Sebastian address. The new address of the corporation is 8802 North U.S. Highway, Sebastian, Florida 32958. The physical address of this corporation is quite unique in that both addresses are located on the same parcel of property but mail is now being delivered by the Postmaster from Sebastian.
