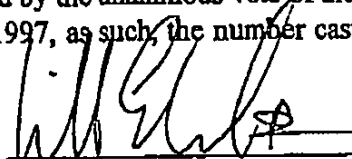

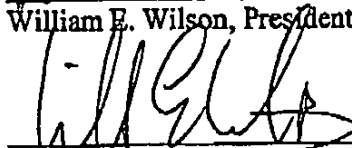
4. All of the property and assets of the corporation have been sold and there are no assets of the corporation to distribute to its sole shareholder.
