Pursuant to the provisions of Section 607.1006 of the Florida Statutes, Physicians Imaging Partnership, Inc., adopts the following Articles of Amendment to its Articles of Incorporation.

1. Article 6 of the Articles of Incorporation is amended to read:

ARTICLE 6. Exercise of Corporate Powers and Management of Corporation

All corporate powers shall be exercised by or under the authority of, and the business and affairs of the Corporation shall be managed under the direction of, its Shareholders. All decisions shall be determined in accordance with the Shareholders' respective percentage interests in the Corporation.

2. Pursuant to Sections 607.0821 and 607.0704, Florida Statutes, all of the Shareholders and the Directors of the Corporation on July 8, 1993, have authorized and consented in writing to the filing of this Amendment to the Corporation's Articles of Incorporation.
