ARTICLES OF DISSOLUTION PURSUANT TO SECTION 607.1403 OF THE FLORIDA BUSINESS CORPORATION ACT OF SONSET INN INCORPORATED

1. Pursuant to the provisions of Sections 607.1403 of the Florida Business Corporation Act, the undersigned corporation adopts the following articles of dissolution for the purpose of dissolving the corporation:

- a) The name of the corporation is: SONSET INN, INCORPORATED. The document number is J78581;

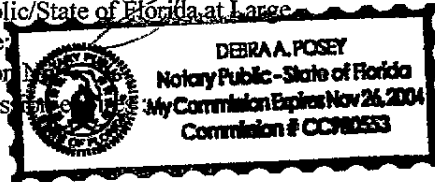
