Pursuant to the provisions of Chapter 607, Florida Statutes, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation filed June 30, 1987, under Document Number J80244, and as thereafter amended from time to time.

Article 1. The corporation is herewith authorized to have in addition to its common stock, Three Hundred Fifty Two Thousand (352,000) shares of preferred stock.

Article 2. The par value of the corporation's shares of preferred stock shall be NO PAR (\$0.00) value per share.

Article 3. The aforesaid amendments were adopted by the Board of Directors on the 5th day of December, 1996 after a resolution of the proposed amendment was adopted by the affirmative vote of the holders of a majority of the shares entitled to vote thereon sufficient for approval of the amendment on the 5 day of December, 1996; said amendment to be effective as of the 30<sup>th</sup> day of December, 1996.
