## ARTICLES OF AMENDMENT

1. The following provisions of the Articles of Incorporation of FLAMBOROUGH GROUP, INC., a Florida corporation, filed in Tallahassee on June 30, 1987 be and they hereby are amended in the following particulars:

> ARTICLE III: PURPOSE, be and it hereby is amended to read as follows:

"The Corporation may only engage in the business of owning and operating the Pinnacle Woods Apartment Complex, Lee County, Florida. This Corporation is a single asset entity and may not own other property other than the Pinnacle Woods Apartment Complex located in Lee County, Florida, and personal property incidental to the operation of the complex."

The foregoing amendment was adopted by the Board of Directors of the 2. corporation on the eighteenth day of May, 1998, by unanimous consent. Shareholder action was not required.
