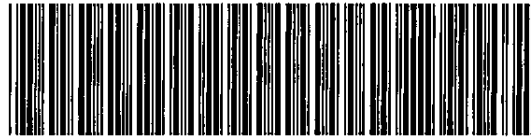

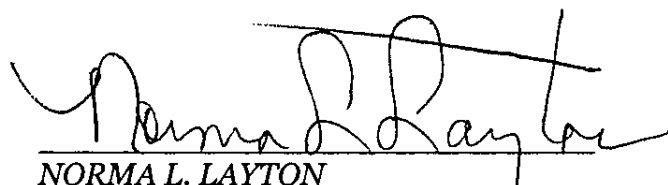
ARTICLE I.
