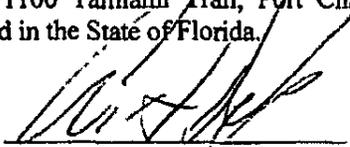
1. The name of this corporation is CHARLOTTE STATE BANK.
2. The original Articles of Incorporation were filed with the Secretary of State on July 7, 1987 and assigned Document Number J81300.
3. The Articles of Incorporation were previously amended by Articles of Amendment filed with the Secretary of State on February 5, 2003.
4. The undersigned officers of Charlotte State Bank, Port Charlotte, Florida, do hereby certify that the Board of Directors of said financial institution approved and proposed to the shareholders thereof, amendment to Article I of the Articles of Incorporation as set out herein, and that thereafter on the 18th day of July, 2011, at a special meeting of the shareholders called and held in compliance with Section 607.1006, Florida Statutes, and with the Articles of Incorporation and Bylaws of said corporation at its office in Port Charlotte, Florida, at which meeting the holders of a majority of the outstanding capital stock were present. There is only one class of stock, and a majority, which was sufficient for approval, approved the amendment changing the name of the corporation to Charlotte State Bank & Trust and amending Article I of the Articles of Incorporation so that effective January 1, 2012, in lieu of its present language it shall read:

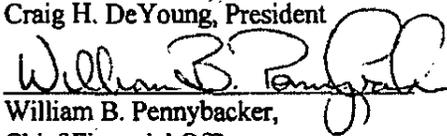

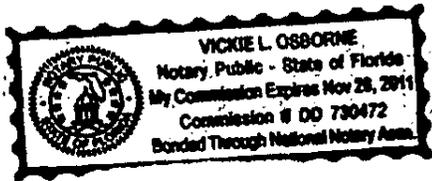

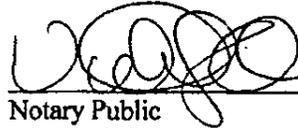
