## ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF CHARLOTTE STATE BANK J81300

Pursuant to the provisions of section 607.1006, Florida Statutes, this Florida profit corporation adopts the following articles of amendment to its articles of incorporation:

- 1. The name of the corporation is CHARLOTTE STATE BANK, a Florida corporation, (the "Corporation").
- 2. The Articles of Incorporation were filed with the Secretary of State on July 7, 1987 and assigned document number J81300.
- 3. Article II of the Articles of Incorporation are amended to read as follows:

### **ARTICLE II**

The general nature of the business to be transacted by this corporation shall be: That of a general commercial banking business and for the purpose of conducting trust business with all the rights, powers, and privileges granted and conferred by the Florida Banking Code, regulating the organization, powers and management of a banking corporation.

- 4. This Amendment was recommended by the board of directors to the Corporation's shareholders and was adopted on December 9, 2002.
- 5. This Amendment was approved by the holders of a majority of the Corporation's common stock, which is the only group of the Corporation's shareholders entitled to vote on the Amendment, and the number of votes in favor of the Amendment was sufficient for approval.
