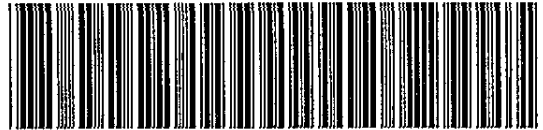

3. The number of shares cast by the shareholders in favor of dissolution was sufficient for approval.

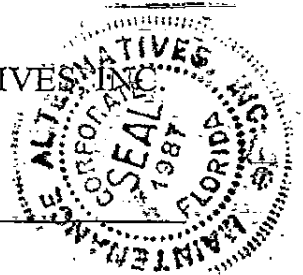
