

SECOND AMENDMENT TO ARTICLES OF INCORPORATION OF READY BANK OF FORT WALTON BEACH

WHEREAS, an Amendment to the Articles of Incorporation to the Articles of Incorporating of the "Bank" was approved by the Department of Banking and Finance on the 12th day of March, 1993, and approved and filed with the Secretary of State of the State of Florida on the 15th day of March, 1993; and

WHEREAS, this proposed Second Amendment to the Articles of Incorporation of the "Bank" was approved by the Board of Directors on the 11 day of March, 1997, pursuant to § 607.1002, Florida Statutes; and

WHEREAS, pursuant to § 655.043, Florida Statutes, the written approval of the Department of Banking and Finance has been obtained; and

WHEREAS, the name READY BANK OF WEST FLORIDA was reserved on February 18, 1997, said reservation number R97000000795.

NOW THEREFORE, the Articles of Incorporation of the "Bank" are hereby amended by deleting in its entirety, the present Article I and by substituting the following:

ARTICLE I

The name of the corporation shall be READY BANK OF WEST FLORIDA, with its principal place of business at 71 North Beal Parkway, Fort Walton Beach, Okaloosa County, Florida.

IN WITNESS WHEREOF, the undersigned, constituting all of the Board of Directors of the "Bank" have adopted at a duly called Board of Directors Meeting, the foregoing Amendment, without shareholders action inasmuch as shareholders action was not required under § 607.1002, Florida Statutes.
