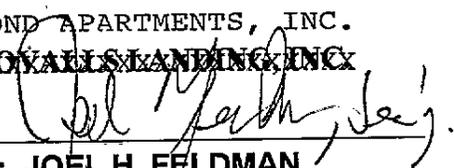
**ARTICLE II:** The date of authorization to dissolve this corporation was December 31, 2001.

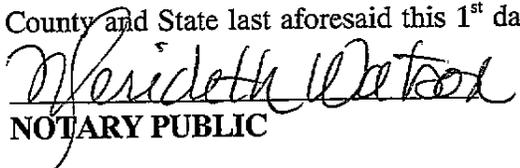
