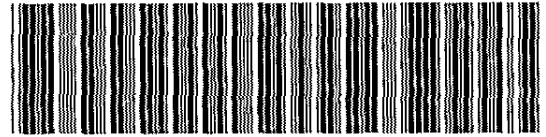

Pursuant to the provisions of Section 607.1101, Florida Statutes (2005), the undersigned corporations hereby adopt the following Articles of Merger:

**ARTICLE I  
PLAN OF MERGER**

The *Plan of Merger* of **MAYFAIR SERVICES INC.**, a Florida corporation, with and into **JANCY SERVICES, INC.**, a Florida corporation, with **JANCY SERVICES, INC.** being the surviving corporation, is attached hereto as Exhibit "A".

**ARTICLE II  
ADOPTION OF PLAN OF MERGER**

The *Plan of Merger* was approved by the shareholders and the directors of each corporation by written consents dated as of the 11th day of May, 2005.

**ARTICLE III  
EFFECTIVE DATE OF MERGER**

The effective date of the Merger shall be as of the 11th day of May, 2005.

**PLAN OF MERGER OF  
MAYFAIR SERVICES INC.  
WITH AND INTO JANCY SERVICES, INC.**

1. **MAYFAIR SERVICES INC.**, a Florida corporation ("Mayfair"), shall merge with and into **JANCY SERVICES, INC.**, a Florida corporation ("Jancy"), with Jancy as the surviving corporation.

2. Upon the consummation of the merger of Mayfair with and into Jancy, the separate existence of Mayfair shall cease. Jancy, as the surviving corporation, shall continue to exist by virtue of the laws of the State of Florida. The title to all property of every description, whether real or personal, and all interests, rights, privileges, powers and franchises of Jancy shall not be affected by the merger and upon the merger, Jancy, without further act or deed and without reversion or impairment, shall own and possess all property of every description, real or personal, and all interests, rights, privileges, powers and franchises of Mayfair as provided in Section 607.1106, Florida Statutes. Further, as provided in Section 607.1106, Florida Statutes, all rights of creditors and any person or persons dealing with Mayfair shall be preserved and remain unimpaired by the merger, all liens upon the properties of Mayfair shall be preserved and remain unimpaired by the merger, and all debts, liabilities, obligations and duties of Mayfair shall henceforth attach to Jancy and may be enforced against Jancy to the same extent as if such obligations and duties have been incurred by Jancy. Additionally, any existing claim or action or proceeding pending by or against Mayfair or Jancy may be continued as if the merger did not occur or Jancy may be substituted in such proceedings for Mayfair.

3. At the effective date of the merger all of the issued and outstanding shares of capital stock of Mayfair shall be cancelled.

4. The Articles of Incorporation of Jancy in effect at the time of the merger shall remain unchanged as a result of the merger and shall continue as the Articles of Incorporation of Jancy.

5. The effective date of the Merger shall be as of the 11th day of May, 2005.
