Pursuant to the provisions of the Florida Business Corporation Act, Central Credit Services, Inc. hereinafter named (the "Corporation") does hereby amend and restate its Articles of Incorporation as heretofore amended.

1. The name of the Corporation is Central Credit Services, Inc.
2. The text of the Restated Articles of Incorporation of the Corporation, as further amended hereby, is annexed hereto as Exhibit A and made a part hereof.

It is hereby certified that:

1. The annexed Restated Articles of Incorporation contain amendments to the Articles of Incorporation of the Corporation requiring shareholder approval.
2. The Articles of Incorporation of the Corporation are hereby amended so as henceforth to read as set forth in the Restated Articles of Incorporation annexed hereto as Exhibit A and made a part hereof.
3. The date of adoption of the aforesaid amendments was February 29, 2008.
4. Only one voting group of shareholders was entitled to vote on the said amendments and restatement.
5. The number of votes cast for the said amendments and restatement by the said voting group of shareholders was sufficient for the approval thereof.

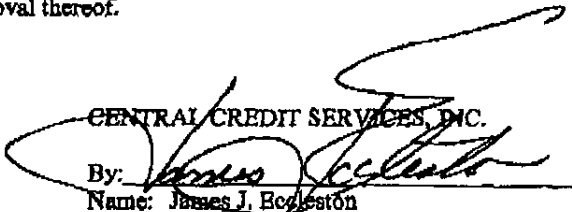

RESTATED ARTICLES OF INCORPORATION
OF
CENTRAL CREDIT SERVICES, INC.

ARTICLE I: The name for the corporation (hereinafter called the "Corporation") shall be Central Credit Services, Inc.
