Pursuant to the provisions of Sections 607.1003 and 607.1006 of the Florida Business Corporation Act (the "FBCA"), the undersigned corporation hereby executes and submits for filing with the Department of State, State of Florida these Articles of Amendment to its Articles of Incorporation:

1. The name of the corporation is AGUIRRE INTERNAL MEDICINE GROUP OF THE PALM BEACHES, INC. (the "Corporation").

2. ARTICLE I of the Corporation's Articles of Incorporation is hereby amended by deleting the text of ARTICLE I in its entirety and substituting the following in lieu thereof:

The name of this corporation is AGUIRRE HEALTHCARE GROUP, INC."


