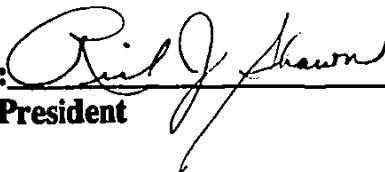
1. The name of the corporation is EAST COAST DENTAL MANAGMENT, INC.
