Gentlemen:

I am writing on behalf of the above taxpayer. The taxpayer received the second notice 1997 Annual Report that states he will have to pay \$385 fee for not filing the Annual report on time.

My client has no problems paying the yearly annual report and has always paid this yearly annual fee on time. When the taxpayer receives the annual report, he always signs the return and mails it back along with the necessary check. This year, he never received the notice and therefore did not realize that he was not complying with the law.

My client and I both feel that the penalty is not justified in this particular case since he did not receive the first notice. In addition, I would like to add, this is not like an income tax or payroll tax return, wherein the client goes to his CPA who tells him when the tax return is due and how much is owed. In this case he gets a notice and he sends a return with the payment when the state notifies him that it is due.

My client is forwarding his check in the amount of \$165, as we do feel that the late penalty should be abated.
