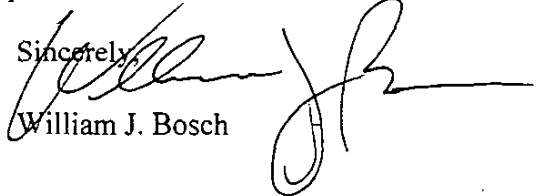
On behalf of Mr. Joseph H. Gardner, and FARMCO ELECTRIC CO., INC., I hereby resubmit his application for an Electrical Contractor's License, together with the additional information which was requested by letter dated September 10, 2004 (a copy of your request is enclosed for reference).

It appears the problem with the August 26, 2004 application was the fact that my client has been operating his company for many years as "Farmco Electric Co., Inc.", and was certified under that name, conducting business under that name, and had all legal documents under that name; however, he was unaware that the incorporation documents filed with the state many years ago, listed his corporate name as "Farmco, Inc." While this was never a problem before, apparently your Department noticed the discrepancy upon his application this past year, and rejected the application until such time as this could be corrected.

The correction has been accomplished through filing Articles of Amendment to the Articles of Incorporation, officially changing the corporate name to Farmco Electric Co., Inc. This amendment became effective November 15, 2004. We include a copy of the Articles of Amendment of Farmco, Inc., demonstrating this change to Farmco Electric Co., Inc. With that change, we resubmit the application for your approval, together with the additional documentation requested in September.

If there is any additional information or documentation required to complete the application process, please notify me at the address listed below. I thank you for your attention to this matter and I look forward to completing this process on behalf of Mr. Gardner.
