AMENDED AND RESTATED ARTICLES OF INCORPORATION OF

ADVANTIS REAL ESTATE SERVICES COMPANY

Pursuant to the provisions of §607.1007 of the Florida Business Corporation Act, the undersigned corporation pursuant to resolutions approved by the sole shareholder and duly adopted by its board of directors, adopts the following restated and amended articles of incorporation which shall supersede the original articles of incorporation filed with the Florida Secretary of State on September 4, 1987, including all amendments thereto.

Article I - Name

The name of the corporation (the "Company") shall be Advantis Real Estate Services Company.

Article II - Principal Place of Business and Mailing Address

The principal place of business shall be located at 1650 Prudential Drive, Suite 400, Jacksonville, Florida 32207 and the mailing address shall be 1650 Prudential Drive, Suite 400 - Legal Dept., Jacksonville, Florida 32207.

Article III - Purpose

The general nature of the Company shall be to conduct any lawful business permitted under the laws of the State of Florida, unless otherwise stated in its bylaws and other states the Company may be authorized to transact business.

Article III - Stock

The maximum number of shares of stock that the Company is authorized to have outstanding at any time is one hundred (100) shares having a ten dollar (\$10.00) par value, all of which shall be common stock of the same class. All shares of common stock issued shall be fully paid and non-assessable. The Company shall have the right to issue fractional shares.

Article IV - Duration

The Company shall have perpetual existence.
