Our client, Najger and Associates Inc., received a Notice of Administrative Dissolution or Revocation for the corporation. As registered agent for Najger and Associates Inc., Sharon Najger was responsible for filing the 2001 Annual Report. However, her husband was diagnosed with cancer and they were in Germany while Mr. Najger participated in a research program to treat his particular type of cancer. Consequently, since Sharon Najger accompanied her husband to Germany, she was unable to submit the 2001 Annual Report for Najger and Associates Inc.

Though we understand that there is no provision in the statutes to waive fees, we request that an exception be made given the extenuating circumstances Mr. and Mrs. Najger have encountered this year. To support their position, we are enclosing a copy of their 2000 tax return, which itemizes their substantial medical bills of \$29,564.00 on Schedule A. We can provide further documentation if it is required. Therefore, please review this situation and advise us on how to proceed.
