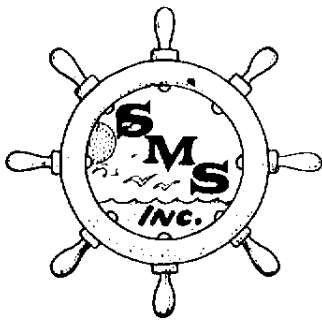

This letter is in reference to the above captioned Florida Corporation.

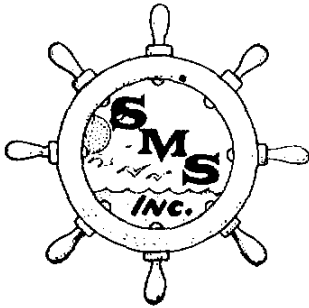
A meeting of the Officers was held and submitted to the minutes July 16, 1997.
