These Articles of Amendment to the Articles of Incorporation of **Riverside Waterproofing, Inc.**, a Florida for profit corporation (*the "Corporation"*), are adopted and filed pursuant to the provisions of Sections 607.1001, 607.1003, 607.1006, and 607.1009, Florida Statutes, as amended, having been duly authorized, approved and adopted by the Shareholders and Directors of the Corporation pursuant to the Bylaws and Articles provisions providing for amendment to the Articles of Incorporation, and shall be effective upon the date of filing with the Secretary of State of Florida.
