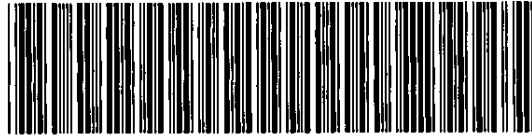

**"The name of the corporation is CIC of Jacksonville, Inc."**


3. The date of adoption of the foregoing amendment was December 18, 2007.
